Instructions for candidates provisionally selected for PG Programme 2019

1. Candidates will be provisionally admitted on payment of prescribed fees of Rs. 10000/- and on submission of duly filled in admission form to SPA Bhopal on or before **21st April 2019**. The amount will be adjusted in the payment of institute Fees.
2. Candidates are required to submit the stipulated fees (Rs.10000/- Ten Thousand Only) to reserve the provisional seat and duly filled in admission form on or before given date i.e. **21st April 2019**, failing which right of admission shall be forfeited/ cancelled and no further communication shall be entertained in this regard.
3. Institute fees (Rs. 69450/- for 1st semester only) can be paid online through SBI I-collect only. Following is the link for SBI I-collect <https://www.onlinesbi.com/prelogin/icollecthome.htm>
4. Candidates are required to submit scanned copy of duly filled up admission form (Annexure -A) along with fees submission receipt/ proof of payment through email to admission@spabhupal.ac.in
5. SC/ST candidates are exempted from the payment of stipulated fees of Rs. 10000/- and tuition fees of Rs. 25000/- per semester.
6. Candidates are required to report at SPA Bhopal from **10th to 12th July 2019** for registration.

At the time of reporting to the Institute for registration following documents are required:-

1. **Original documents in support of eligibility criteria pertaining to educational qualification, Category certificate etc., failure to produce certificates and testimonial in original and failure to secure prescribed eligibility for admission within a reasonable time period shall invite cancellation of the admission at any stage.**
2. Migration certificate for candidates whose final results are awaited.
3. One set of self attested photocopies of all the mark sheets along with other relevant documents.
4. Passport size colour photograph (4 copies).
5. SC/ST/OBC/EWS Category need to submit Caste /Category certificate as per Central Government format/proforma at the time of admission /Registration . The format /Proforma of these certificates are available on SPA Bhopal web site (<http://spabhupal.ac.in>). PH candidate to submit as per prescribed format by issuing authority.
